## POSITION PURPOSE STATEMENT

The Program Manager (Co-Design) for Statewide Programs will have an outstanding opportunity to improve outcomes for young people across Victoria in need of equitable access to evidence-informed tertiary and quaternary mental health treatment, care, and support.

They will be highly motivated and skilled, with the abilities to lead, design and deliver the programs codesign activities as part of a matrix team including partner organisations, including convening communities of experience and expertise across the state to collaborate in system reform and transformation. They will have demonstrated excellent skills in program management and codesign. They will also be an excellent communicator with experience of working with poorly and underserved communities. They will be comfortable managing multiple tasks, while being a strong team player with an aptitude for problem-solving. They will be expected to work with a high degree of autonomy with partners under the direction of the Program Director.

Working across Orygen's Knowledge Translation and Clinical Operations Divisions and in close collaboration across the state with clinical and other colleagues, young people, their families, and communities, the Project Manager will have the opportunity to use their knowledge, skills and abilities in youth mental health transformation.

### POSITION KEY RESPONSIBILITY AREAS

- Ensure that Statewide Program activities are delivered on-time, within scope and to budget.
- Ensure the credibility of the Statewide Program codesign activities with partners.
- Lead the development, planning and delivery of the program's codesign projects, producing codesign project scopes, objectives, and feasible plans, by involving appropriate stakeholders.
- Actively manage and oversee engagement, collaboration and codesign activities with partners to understand and respond to their needs, effectively managing expectations within each project horizon.
- Establish, manage, and maintain relationships with partners and vendors as required.
- Support the establishment of the program advisory groups as core to program governance; and ensure their effective and efficient utilisation to inform and steer the program to deliver the Activity Work Plan objectives.
- Contribute to the development and implementation of the broader program management methodology, including the standardised tools, processes, systems, monitoring, reporting, and governance mechanisms required to deliver the program.
- Ensure resource availability (including supporting recruitment); and effective allocation across the engagement, collaboration and codesign activities to deliver the program.
- Create and maintain comprehensive partnership documentation to support evaluation and continuous improvement.
- Develop and implement risk management assessments and processes to monitor and minimise project risks, report and escalating issues as required.
- Use appropriate verification techniques to manage changes in scopes, schedule, and costs.
- Ensure excellent internal monitoring and communication of engagement, collaboration and codesign to ensure that all staff are fully informed at all stages of timelines, scope, and roles and responsibilities, risks and issues.
- Facilitate program and project status meetings and stand-ups.
- Compilation of all products and documents required as required for internal and external governance.
- Support colleagues across program activities to help them deliver on their priority activities.
- Role model the Orygen purpose and values and participate in the building of a strong team culture that drives employee engagement and trust.
- Any other duties, as reasonably requested by the Program Director.
- Comply with and support others to comply with Orygen's policies and procedures, including taking appropriate action to hold others accountable and promote a workplace culture that is safe, diverse and inclusive.
